All these Scholarship Schemes are online schemes and one can apply for fresh or renewal scholarship under the eligible scheme on <https://mahadbtmahait.gov.in> The extended last date for applying online is **07/03/2022.** After filling the online form, the applicant is required to take a print out of the online form and submit it in the college office for further process with the relevant necessary documents as mentioned below **on or before 07/03/2022.** The sanctioned amount of scholarship will be directly transferred by the Government to Aadhar linked Bank Account (Under DBT Mode) of the student.

Note : 1) Students of **B.M.S./B.Sc.(IT)/M.Com.(Busi.Mgt.)** class kindly take note that the scholarship schemes for **OBC/SBC/VJNT/SEBC/EWS** category are not available by the Government.
