विद्यार्थ्यांना कळविण्यात येते की खाली नमूद केंद्र शासन पुरस्कृत विविध शिष्यवृत्ती योजना सन २०२३-२४ विद्यार्थ्यांकरिता राबविण्यात येतात. यासाठी विद्यार्थ्यांचे नवीन शिष्यवृत्ती (Fresh) व शिष्यवृत्तीचे नुतनीकरण (Renewal) करण्यासाठी ऑनलाईन पध्दतीने अर्ज मागविण्यात येत आहेत. विद्यार्थ्यांनी www.scholarships.gov.in या संकेतस्थळावरून ऑनलाईन (Online) पध्दतीने वाढीव अंतिम दिनांक ३१/१०/२०२३ पर्यंत अर्ज भरणे आवश्यक आहे. विद्यार्थ्यांस मंजूर झालेल्या शिष्यवृत्तीची रक्कम केंद्र शासनामार्फत थेट विद्यार्थ्यांच्या आधार लिंक बँक खात्यात (Under DBT Mode) जमा करण्यात येईल. याकरिता सर्व विद्यार्थ्यांना कळविण्यात येते की त्यांचे बँक खाते क्रमांक चालू स्थितीत (Operative/Active Mode) असणे आवश्यक आहे. जेणेकरून शिष्यवृत्ती रकमेचे वितरण अयशस्वी (Fail) होणार नाही.

- 3) दिव्यांगजन विद्यार्थ्यांसाठी पोस्ट मॅट्रिक शिष्यवृत्ती योजना

अर्ज करण्याची पध्दत (नवीन मंजूरी / नुतनीकरण) :

- 1) शिष्यवृत्ती योजनेच्या मार्गदर्शक तत्वानुसार पात्र व इच्छुक विद्यार्थ्यांनी www.scholarships.gov.in या संकेतस्थळावरून ऑनलाईन पध्दतीने अर्ज भरणे आवश्यक आहे.
- 2) National Scholarships (NSP) या मोबाईल ॲपची सुविधा देखील अर्ज भरण्यासाठी देण्यात आली आहे.
- 3) ऑनलाईन अर्ज भरण्यापूर्वी विद्यार्थ्यांनी उपरोक्त संकेतस्थळाच्या Homepage वरील Guidelines व Frequently Asked Questions (FAQs) वाचून व समजून घेऊनच ऑनलाईन अर्ज भरावा.
- 4) ऑनलाईन अर्ज भरताना काही अडचण निर्माण झाल्यास आपल्या महाविद्यालयाशी संपर्क साधून सदर अर्ज महाविद्यालयाच्या मदतीने पूर्ण करून घ्यावा. सदर शिष्यवृत्ती लाभ मिळण्यासाठी आपला अर्ज ऑनलाईन सिस्टीममध्ये येणे अनिवार्य आहे.
- 5) विद्यार्थ्यांनी ज्या अभ्यासक्रमास प्रवेश घेतला आहे त्या अभ्यासक्रमाच्या प्रथम वर्षी शिष्यवृत्ती मंजूर झाल्यानंतर अभ्यासक्रम पूर्ण होईपर्यंत विद्यार्थ्यांनी नुतनीकरणासाठीच अर्ज भरावा.
- 6) ऑनलाईन अर्ज भरून होताच विद्यार्थ्यांनी त्याची प्रिंट घ्यावी व त्यासोबत आवश्यक ती कागदपत्रे जोडून महाविद्यालयीन कार्यालयामध्ये पुढील कार्यवाहीसाठी ३१/१०/२०२३ पर्यंत नवीन शिष्यवृत्तीकरिता (Fresh) व नूतनीकरण शिष्यवृत्तीकरिता (Renewal) सादर करावीत.

Therefore, students are hereby informed to keep their bank account active/operational to get the scholarship amount without transaction failure.

Procedure for Applying (Fresh and Renewal) :

- 1) The scheme is implemented through the National Scholarship Portal (NSP). It is mandatory for all students to apply online on the website i.e. **www.scholarships.gov.in**.
- 2) Before applying online; the students are asked to go through the detailed instructions for filling in online application (Guidelines) and 'Frequently Asked Questions (FAQ)' on the National Scholarship Portal Homepage.
- 3) The Applicant can contact college office for resolving the problem while filling the online form.
- 4) After filling the online form, the applicant is required to take a print out of the online form and submit it in the college office for further process with the relevant necessary documents as mentioned above **on or before 31/10/2023.**
- 5) If a student is found to have obtained a scholarship by false statement, his/her scholarship will be cancelled forthwith and the amount of the scholarship paid will be recovered from the student.
- 6) A scholarship holder under this scheme will not hold any other scholarship/stipend.
