As per this law ragging is crime within the campus of college which includes all buildings in the premises, Canteen, Gymkhana, Ladies Common Room etc. and 100 meters area outside college gate. If any student is found guilty of ragging, he or she will be punishable which may be a jail of 2 years and/or fine up to Rs.10,000/-. Students are required to take strict note of this and not to involve in any act which may amount to ragging. Any student who wants to file complaint of ragging should contact Convener of committee Prof. N. N. Varade or member Prof. Ms. D. B. Mulmulay.

### Procedure To Handle The Cases-

1. To uphold and comply with the directions of the Hon'ble Supreme Court and be vigilant on any acts amounting to ragging.
2. To publicize to all students and prevalent directives and the actions that can be taken against those indulging in ragging.
3. To consider the complaints received from the students and conduct enquiry and submit report to the Anti- Ragging Committee along with punishment recommended for the offenders.
4. To oversee the procedure of obtaining undertaking from the students in accordance with the provisions.
5. To conduct workshops, seminars, webinars, conferences, symposia...etc... against ragging menace and orient the students.
6. To provide students the information pertaining to contact address and telephone numbers /emails of the person(s) /committee identified to receive complaints/distress calls.
7. To offer services of counseling and create awareness to the students.
8. To take all necessary measures for prevention of Ragging inside the Campus.



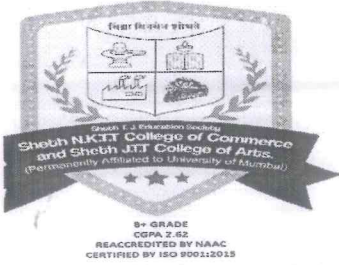

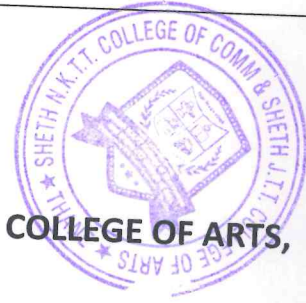

▪ Grievance Redressal Mechanism:


1. The Cell will entertain both, written and signed complaints as well as complaints received through e-mails [-----] addressed to the Institution.

**SoP of Internal Committee**

1. An aggrieved woman employee/ female student of the college should give a written complaint either in person or through post or email to [shethnktticc@gmail.com](mailto:shethnktticc@gmail.com). The aggrieved should give the complaint within three months of the date of the incident. If the aggrieved woman is unable to make a complaint, her legal heirs may do so.
2. On receiving the complaint, the IC will inquire as per regulations under the Act. The committee will complete them within 90 days. The committee will submit the report within ten days from the date of completion of the inquiry.
3. If the IC finds that the allegations against the respondent are proven, it will submit a report to the Principal to take action for sexual harassment as misconduct as per rules framed under the Act.
4. The college management will act on the recommendations of IC within 60 days of the submission of the inquiry report.
5. In case of complaint against any of the committee member of IC, complaint can be filed to Hon'ble Management of the Institute.
6. Appeal against the decision of the IC is allowed within 90 days of the recommendations.
